Saints should always be judged guilty until they are proved innocent, but the tests that have to be applied to them are not, of course, the same in all cases. In Gandhi's case the questions on feels inclined to ask are: to what extent was Gandhi moved by vanity - by the consciousness of himself as a humble, naked old man, sitting on a praying mat and shaking empires by sheer spiritual power - and to what extent did he compromise his own principles by entering politics, which of their nature are inseparable from coercion and fraud? To give a definite answer one would have to study Gandhi's acts and writings in immense detail, for his whole life was a sort of pilgrimage in which every act was significant. But this partial autobiography, which ends in the nineteen-twenties, is strong evidence in his favor, all the more because it covers what he would have called the unregenerate part of his life and reminds one that inside the saint, or near-saint, there was a very shrewd, able person who could, if he had chosen, have been a brilliant success as a lawyer, an administrator or perhaps even a businessman.

At about the time when the autobiography first appeared I remember reading its opening chapters in the ill-printed pages of some Indian newspaper. They made a good impression on me, which Gandhi himself at that time did not. The things that one associated with him - home-spun cloth, "soul forces" and vegetarianism - were unappealing, and his medievalist program was obviously not viable in a backward, starving, over-populated country. It was also apparent that the British were making use of him, or thought they were

making use of him. Strictly speaking, as a Nationalist, he was an enemy, but since in every crisis he would exert himself to prevent violence - which, from the British point of view, meant preventing any effective action whatever - he could be regarded as "our man". In private this was sometimes cynically admitted. The attitude of the Indian millionaires was similar. Gandhi called upon them to repent, and naturally they preferred him to the Socialists and Communists who, given the chance, would actually have taken their money away. How reliable such calculations are in the long run is doubtful; as Gandhi himself says, "in the end deceivers deceive only themselves"; but at any rate the gentleness with which he was nearly always handled was due partly to the feeling that he was useful. The British Conservatives only became really angry with him when, as in 1942, he was in effect turning his non-violence against a different conqueror.

But I could see even then that the British officials who spoke of him with a mixture of amusement and disapproval also genuinely liked and admired him, after a fashion. Nobody ever suggested that he was corrupt, or ambitious in any vulgar way, or that anything he did was actuated by fear or malice. In judging a man like Gandhi one seems instinctively to apply high standards, so that some of his virtues have passed almost unnoticed. For instance, it is clear even from the autobiography that his natural physical courage was quite outstanding: the manner of his death was a later illustration of this, for \vec{a} public man who attached any value to his own skin would have been more adequately guarded. Again, he seems to have been quite free from that maniacal suspiciousness which, as E. M. Forster rightly says in A Passage to India, is the besetting Indian vice, as hypocrisy is the British vice. Although no doubt he was shrewd enough in detecting dishonesty, he seems wherever possible to have believed that other people were acting in good faith and had a better nature through which they could be approached. And though he came of a poor middleclass family, started life rather unfavorably, and was probably of unimpressive physical appearance, he was not afflicted by envy or by the feeling of inferiority. Color feeling when he first met it in its worst form in South Africa, seems rather to have astonished him. Even when he was fighting what was in effect a color war, he did not think of people in terms of race or status. The governor of a province, a cotton millionaire, a half-starved Dravidian coolie, a British private soldier were all equally human beings, to be approached in much the same way. It is noticeable that even in the worst possible circumstances, as in South Africa when he was making himself unpopular as the champion of the Indian community, he did not lack European friends.



While the car was being taken on the cart, the car slips down and as a result of which Mr. 'B', a passerby dies. Wife of Mr. 'B' files a case u/s 166 of the Motor Vehicles Act 1988. Is her case maintainable in the Tribunal? Please give reasons in support of your answer.

- 3.1 A school master wrongfully refused to permit a ten year old boy to leave the school unless the school fee is paid. The child was not even conscious of the detention. Please discuss the liability of the school master?
- 3.2 The plaintiff's little kitten trespasses over the defendant's land. The defendant's pet tiger pounced on the kitten and injured the kitten badly. The plaintiff brought an action for damages against the defendant. Will he succeed?
- 3.3 "When the rule of immunity in favour of the Crown has disappeared from the land of its birth, there is no legal warrant for holding that it has any authority in India, particularly after the Constitution." Please Comment.
- 3.4 Mr. Ramesh, who is a practicing advocate while on vacation with his wife. They met with an accident, while driving his car. The accident was on account of the negligence of truck driver Mr. Ashok. As a result of the accident, Mr. Ramesh was seriously injured and was admitted in the hospital. He underwent treatment at the hospital, his wife incured total expenses of Rs.10 Lakhs on the treatment. Ultimately on account of the serious injuries Mr. Ramesh died. Mrs Ramesh filed an application u/s 166 of the Motor Vehicles Act, 1988. Followings facts were presented to the Tribunal.





(a) Age of Mr. Ramesh: 36 years.

(b) Income (per Month): Rs. 25,000.

(c) Total no. of Dependants: 3 (wife and two children)

(d) The truck was insured.

The Motor Accident Claims Tribunal awards a sum of Rs. 10 Lakhs in total as compensation and in addition awards Rs. 15,000 for medical expenses by relying upon the second schedule of the *Motor Vehicles Act* 1988.

Is the award of the Tribunal Correct? Please discuss in light of the ratio laid down by the Honorable Supreme Court in the case of Sarla Verma v. Delhi Transport Corporation Ltd. Also give detailed reasons in support of your answer.
