# Answer any five questions from the following. All questions carry equal marks.

1. Princess Loraine is a very powerful ruler of the Kingdom of The Misty Mountains. She has a lot of enemies owing to her intelligence, managerial capabilities, and use of the most advanced technologies to combat the threats posed by the neighbouring kingdoms. She has installed some of the finest computer systems in her kingdom for use in educational institutions, banks, and other commercial initiatives.

However, a certain newspaper, *The Precious Daily*, run by a man named Smeagol G., based in the Kingdom of The Blue Mountains, published a news piece with the information that Princess Loraine of the Misty Mountains was seen having a private time with the Prince of the Blue Mountains. He published blurred images of the Princess and the Prince in his newspaper.

You are a Legal Advisor in the Ministry of Law at the Kingdom of The Misty Mountains.

- (a) Please advise Princess Loraine about the feasibility of pursuing a legal action against Smeagol G., keeping in view the relevant provisions of The Information Technology Act of the Kingdom of The Misty Mountains. It is identical to the Information Technology Act, 2000 of the country of India. Also, mention the relevant case-law.
- (b) Discuss in brief, the evolution of the right to privacy in India, starting from the *Kharak Singh* case to the recent *Justice Puttaswamy* case.
- 2. Porsche had filed an action in rem against 128 domain names that incorporated variations on the registered trademarks "Porsche" and "Boxster". Explain the jurisdictional issues that e-commerce companies such as Porsche may face, *in personam* and *in rem*, with reference to the relevant provisions of the Code of Civil Procedure, 1908, and relevant US case-law.
- 3. In *Infotech Software Dealers Association v. Union of India*, there was a discussion about software as goods or services. Review the case, discussing the legal issues, and the reasons which led the court to come to a conclusion about the nature of software.
- 4. Mr. B. Wayne is a Senior Agent with the Cyber Intelligent Unit of the city of Gotham. He is in charge of ensuring that the cyber-crimes committed within the city are either prevented or addressed immediately. He gets a call from an employee with the Oriental Bank of Gotham at 08:15 pm who claimed that a person by the name of "Joker" has stolen all the sensitive personal information belonging to their customers from their

computer systems. After a brief investigation, Mr. Wayne determines that such data was stolen by the means of identity theft and cheating by personation.

You are one of the Legal Advisors in the Ministry of Law and Justice at the city of Gotham. Mr. Wayne consults you and seeks your advice before taking any action against the so-called, "Joker".

Discuss:

- (a) In brief, the types of credit card frauds that can take place by the use of the Internet.
- (b) Whether the Oriental Bank of Gotham can pursue legal action against the perpetrator, with reference to relevant provisions of the Information Technology Act, which is identical to the Information technology Act, 2000 of the country of India.

- (b) Trademark infringements via the Internet with reference to Indian cases [at least 4].
