
2. CHANCELLORS OF THE UNIVERSITY

4.4 CONDUCT OF COMMON LAW ADMISSION TEST (CLAT) - 2018

Common Law Admission Test is the most coveted entrance examination for students aspiring to pursue under-graduate or post-graduate course in Law from the prestigious National Law Universities of the country. Common Law Admission Test, 2018 was conducted under the aegis of the National University of Advanced Legal Studies (**NUALS**), Kochi. Over 50,000 students appeared in the examination held on the 13th May while only 2300 (approx.) of them were able to reach their destined National Law University (NLU) for pursuing their career in law. National Law University and Judicial Academy, Assam which is the CLAT Zonal Office for the North-East conducted the Common Law Admission Test (CLAT). Faculty members of the University, in their capacity as Centre Observers, oversaw the smooth conduct of online Admission Test held in the states of Assam, Meghalaya and Manipur.

CLAT - 2018 was conducted in N.E. region under the supervision of Prof. (Dr.) J.S. Patil, Vice-Chancellor, Zonal Coordinator and Mr. Miftahuddin Ahmed, Registrar, Cocoordinator, CLAT - 2018 at the following centres along with Centre Observers:

- (i) Studylink Academy, Guwahati-9 (Ms. Kasturi Gakul, Assistant Professor of Law and Centre Observer) 184 candidates attended out of 200.
- (ii) Assam Online, Gotanagar, Guwahati-11 (Mr. Himangshu Ranjan Nath, Assistant Professor of Law) 361 candidates attended out of 440.
- (iii) Nongnil IT constultants, Loklaobung Gas Building, Imphal-1, Manipur (Mr. Thangzakhup Tombing, Assistant Professor of Law, NLUJA, Assam and Centre Observer) 50 candidates attended the examination.
- (iv) R.K. Mission, Vivekananda Cultural Centre, Shillong-1, Meghalaya (Dr. Topi Basar, Associate Professor of Law and Centre Observer).

4.7.4 Activities of Important Committees

4.7.4.1 The Disciplinary Committee

The Convener along with the members of the Committee has constantly been on the alert to maintain a strict vigilance on all matters in order to maintain discipline in the campus. The Committee has been keeping an eye on all activities in the campus. Violation of any rules or sanctity of the University is strongly dealt with by the Disciplinary Committees for Boys and Girls.

4.7.4.2 The Unfair Means and Malpractice Committee

The Committee looks into all the cases of unfair means and malpractice reported to the same. The Committee also undertakes surprise visits during examinations to keep a strict vigilance on any unfair means and / or malpractice. In order to thwart academic malpractices, the University is equipped with anti-plagiarism software which examines all the project reports and the dissertations submitted by the students. The software filters the contents of the project reports in accordance with the standards of National Law University, Assam Academic Misconduct Regulations.

4.7.4.3 The Internal Complaints Committee

The Internal Complains Committee (ICC) been constituted in accordance with the UGC (prevention, prohibition and redressal of sexual harassment of women employees and students in higher education institutions) Regulations, 2016. The ICC probes every complaint registered with the same and is also entrusted with dissemination of information among the students and staff members of the University.

On August 01, 2018, the ICC Presiding Officer, Dr. Topi Basar conducted an orientation session for the newly admitted students on issues related to sexual harassment at the Seminar Hall of Administrative Building. No case has been reported to ICC in the year 2018-19.

4.7.4.4 The Examination Committee

The Committee is entrusted with monitoring of all examination related activities including preparation of examination schedule; invigilation duty list; preparation and verification of result sheets. The Committee engages itself with upgrading of examination system, grading scale, evaluation scale in concurrence with BCI and UGC guidelines issued from time to time.

4.7.4.5 The Moderation Committee

The Committee is assigned the responsibility of reviewing question papers of all examinations held for the undergraduate and postgraduate courses. Further, this Committee also looks into moderation of marks scored by students in different courses as when required.

5.1 CONTENT AND COLLECTIONS

In the current year, a total number of 1039 books were added to the existing collection. Lexis India Advance is the new addition to the University's electronic resources. Lexis India is the most authoritative online legal information system containing primary legal contents, leading commentaries across various areas of Law.




- IT Section has procured new servers to enhance the IT infrastructure. Further, Desktop computers has been procured for the Computer Lab to increase its operational capacity.

- OpenVPN certificates for the newly admitted students have been created to access the University database remotely.






9.1.1 Student strength with category wise break-up of seats of the students admitted to the Undergraduate Course













IV-Year: 5th batch (2015-20)


9.1.3 Admissions (2018-2019)

March 09 - 10, 2019

The Centre for Environmental Law, Advocacy and Research (CELAR), organised a Two-Day International Conference on Climate Change on 9th and 10th March 2019. It was cosponsored by the prestigious Shastri Programme Development Grant (SPDG) of the binational Shastri Indo-Canadian Institute, New Delhi. The focal area of the Conference was



to explore the multidisciplinary contours of climate change. As such, the conference witnessed the presentation of research made by seventy select people across various academic disciplines, like law, economics, technology, geography, sociology, business, commerce and technology. It also witnessed the scholarly presence of over fifty delegates. The participants hailed from Assam and other places across the length and breadth of India as well as from several foreign countries like Bhutan, Nepal, Bangladesh and Mexico.

The Conference dwelled on three primary themes namely, the international dimension on climate change, focussing specially on the Indo-Canadian dimension and the national and north east Indian dimension on climate change. To stimulate discussions and debates, eminent personalities and experts in each of the thematic dimensions were present. The luminaries included judges like Chief Justice A.S. Bopanna, Justice S. Shyam and Justice U. Bhuyan of Gauhati High Court, Justice P.M.M. Peires, former Chief Justice of the Supreme Court of Sri Lanka and Dr. Ranjan Chatterjee from the National Green Tribunal. It also included lawyers like Mr. Sanjay Upadhay and Mr. Sudhir Mishra of the Supreme Court of India, academicians like Prof. (Dr.) Armin Rosencraz from Stanford University, Prof. (Dr.) Phillip Cullet from SOAS University of London, Prof. (Dr.) M.K. Ramesh from NSLIU, Prof. (Dr.) Chandan Mahanta from IIT-G and activists like Ms. Rama Rauta, Pioneer of the Save Ganga Movement, Mr. Jadav Payeng, the Forest Man of India and Mr. Rajendra Singh, the Waterman of India. Led by such personalities, the technical sessions of the Conference witness some intense deliberations on how best to combat climate change, especially the peculiar climate vulnerabilities of Assam and North East India. The deliberations will soon be consolidated in the form of principles and published as the 'Guwahati Declaration on Climate Change'. The Guwahati Declaration will be presented to the state and other non-governmental stakeholders in order to assist policy and action making aimed to combat change. The Conference will become an annual event and the Guwahati Declaration will be annually amended as and when necessary. The research proceedings of the Conference will be published in the form of a book and be made available to the public.

The event was held from 20th to 22nd April, 2018. The Chief Guest of the opening ceremony was the son of Late Dr. Gurjeet Singh, Mr. Manveen Singh now Assistant Professor at Jindal Global Law School. The competition witnessed a huge turnout of 26 teams out of which 6 were National Law

15.1.2 Vox Anatolis National Moot Court Competition

The Academic Year saw the completion of 1st edition of VOX ANATOLIS National Moot Court Competition namely "The Voice of the East" from 1st to 3rd March, 2019. The concept behind the introduction was to engage law students in legal problems concerning legal situations of the North Eastern part of the country.
